HOME DECOR/HOUSEWARES- Clean, ready to sell, damage and odor free.

FURNITURE- Clean, ready to sell. Free from damage, stain, pet hair and odor. **(We require pictures of furniture prior to consignment to determine ability to sell and available space. Email to the above address)**

PERCENTAGES- Consignors' percentages are as follows:

40% on clothing, accessories, and home decor

60% on furniture you bring to us, includes 8 x 10 rugs or larger

50% on furniture we pick up from you and authentic high end purses

Earnings for sold items can be collected in person at Smith & Co. Consignment during our normal business hours listed above.

CONSIGNMENT PERIOD AND BEYOND

Items will be for sale for 65 days. (Some furniture, up to 3 months upon approval.) By signing this contract you agree that any items dropped off or picked up by Smith & Co. for consignment will not be released before the 65 day consignment period has ended unless an early pick up fee of 20% of the original listed price of each item is paid. You also agree to remove any items from any and all online listings while the items are for sale at Smith & Co. Consignment. At the time of your appointment you will be given a pick up date with instructions to follow when collecting unsold items. Unclaimed items become the property of Smith & Co. Consignment and will be donated to the charity of our choice or to do with as we see fit.

Pricing, promotions, and markdowns of all items are solely at the discretion of Smith & Co. Consignment.

Smith & Co. Consignment will use reasonable care with items placed on consignment, but is not responsible for items in the case of theft, fire or damage. Consignment left at Smith & Co. Consignment is at the risk of the Consignor.
